

PRIVACY NOTICE

This Privacy Notice for Vocabulise ("**We**," "**Us**," or "**Our**"), describes how and why We may access, collect, store, use, and/or share ("**process**") your ("**Your**") personal information when you ("**You**") use Our services ("**Services**"). This includes, for example, when you download and use Our mobile application and engage with Us in other related ways.

Questions or concerns? Reading this Privacy Notice will help you understand your privacy rights and choices. We are responsible for making decisions about how your personal information is processed. If you do not agree with Our policies and practices, please do not use Our Services.

1. What Information Do We Collect?

Personal information you disclose to Us

In Short: We collect information you provide and some automatically for app functionality.

Personal Information You Provide

We collect personal information you voluntarily provide when you register, contact Us, or participate in activities within the Services.

Learning-Related Data

We believe that vocabulary learning is a continuous journey. Unless You request otherwise, we may retain information about Your learning activities and progress so that we can personalize Your learning experience and help You build and maintain Your vocabulary over time.

AI-Powered Learning Features and History

Vocabulise uses AI to provide and enhance various learning features, including generating personalized word lists, translating words and phrases, creating learning stories, and identifying objects in photos to generate vocabulary flashcards.

When You use these features, the information You provide, such as text, photos, or selected words, may be processed by AI to generate learning materials and personalize Your experience. Your generated word lists, translations, stories, flashcards, and related learning activities may be stored in Your account history so that You can access, review, and continue using them over time.

You may request deletion of Your generated content and associated learning history at any time by contacting contact@curieit.com or through Your account settings, where available.

Information Automatically Collected

We automatically collect certain device and usage information, such as device type, operating system, and language. This helps us maintain security, improve functionality, and analyze app performance.

All personal information provided must be accurate and up to date.

2. How Do We Process Your Information?

In Short: We process information to provide services, improve functionality, communicate, ensure security, and comply with law.

We process your information for:

- Providing, maintaining, and improving Our Services (performance of contract)
- Ensuring security and preventing fraud (legitimate interest)
- Processing learning-related data and user-provided content for AI-powered vocabulary generation, translation, story creation, and personalized learning (explicit consent)
- Complying with legal obligations (legal obligation)
- Sensitive personal information is only processed with explicit consent.

3. When and With Whom Do We Share Your Personal Information?

In Short: We may share information with affiliates, service providers, or in business transfers.

We share information in these situations:

- **Business Transfers:** During mergers or acquisitions
- **Affiliates:** Parent company, subsidiaries, or joint ventures under obligations to honor this Privacy Notice.

Service Providers:

- Firebase – backend
- RevenueCat – payment processing

All service providers are contractually bound to protect your information.

4. Do We Use Cookies and Other Tracking Technologies?

In Short: We don't use cookies or other tracking technologies

5. How Do We Handle Your Social Logins?

In Short: If you choose to register or log in to Our Services using a social media account, We may have access to certain information about you.

Our Services offer you the ability to register and log in using your third-party social media account details. Where you choose to do this, We will receive certain profile information about you from your social media provider. The profile information We receive may vary depending on the social media provider concerned, but will often include your name, email address, as well as other information you choose to make public on such a social media platform.

We will use the information We receive only for the purposes that are described in this Privacy Notice or that are otherwise made clear to you on the relevant Services. 6. Is Your Information Transferred Internationally?

While Our servers are located in the EU, your information may be processed in other countries. Transfers are protected by safeguards like Standard Contractual Clauses.

7. How Long Do We Keep Your Information?

In Short: We keep your information for as long as necessary to fulfill the purposes outlined in this Privacy Notice unless otherwise required by law.

We will only keep your personal information for as long as it is necessary for the purposes set out in this Privacy Notice, unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements).

When We have no ongoing legitimate business need to process your personal information, We will either delete or anonymize such information, or, if this is not possible (for example, because your personal information has been stored in backup archives), then We will securely store your personal information and isolate it from any further processing until deletion is possible.

8. Do We Collect Information from Minors?

In Short: We do not knowingly collect data from or market to children under 18 years of age.

We do not knowingly collect, solicit data from, or market to children under 18 years of age, nor do We knowingly sell such personal information. By using the Services, you represent that you are at least 18 or that you are the parent or guardian of such a minor and consent to such minor dependent's use of the Services. If We learn that personal information from users less than 18 years of age has been collected, We will deactivate the account and take reasonable measures to promptly delete such data from Our records.
